What is a UK Interbank Payment?

A UK Interbank Payment is a payment to and/or from an account within the UK in Sterling, excluding Standing Orders or Direct Debits. (For further information please refer to "A Guide to Sterling Current Accounts", available from our Customer Service Unit or online at www.aib.ie)

Where do I send my completed form and what value will be applied to the payment?

- The completed Instruction should be sent to any AIB branch for processing.
- Should any of the information you provide be inaccurate or invalid, your payment may not be made or may be delayed.
- AIB is not responsible for the failure of the receiving bank to pass on this payment to the receiver.

What charges will apply to this payment?

1 Payments less than or equal to £250,000.00 will be charged £10.00. Payments greater than £250,000.00 will be charged £15.00.

Customer (Sender) Details: i.e. details relating to the company/person sending the payment

The payment instruction must be signed by the authorised signatories of the customer account to be debited, confirming that you are instructing the bank to complete this payment and that you have read and agree to be bound by the applicable Sterling Current Account Terms and Conditions.
